The county property tax rates for the preceding fiscal year, and each county property tax rate that has been adopted or calculated for the current fiscal year, including (a) the property tax rate; (b) the effective tax rate; (c) the effective maintenance and operations tax rate; (d) the rollback tax rate; and (e) the debt rate are \$0.5288 per \$100 of valuation. The county property tax rates for the current fiscal year, including (a) the property tax rate; (b) the effective tax rate; (c) the effective maintenance and operations tax rate; (d) the rollback tax rate; and (e) the debt rate are \$0.5447 per \$100 of valuation. The total amount of county debt obligations are: \$0.

This budget will raise more revenue from property taxes than last year's budget by an amount of \$159,246, which is a 7.99% increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$48,755.
