**IN ABUNDANCE OF CAUTION DUE TO COVID 19 AND FOR THE SAFETY AND WELFARE OF THE CITIZENS OF REAL COUNTY AS WELL AS REAL COUNTY EMPLOYEES, I HAVE IMPLEMENTED THE FOLLOWING GUIDELINES FOR THE REAL COUNTY COURTHOUSE:**

- 1. EFFECTIVE WEDNESDAY, MARCH 25<sup>TH</sup> THE REAL COUNTY COURTHOUSE OPERATING HOURS TO THE GENERAL PUBLIC FROM REAL COUNTY ARE FROM 9AM TO 4PM WITH CLOSURE DURING THE NOON HOUR.**
- 2. ENTRY INTO THE COURTHOUSE WILL BE AVAILABLE THROUGH THE SOUTHSIDE DOORS ONLY (by the flagpoles). PLEASE PRACTICE SOCIAL DISTANCING WITH OTHER COURTHOUSE PATRONS.**
- 3. PLEASE TRY TO CONDUCT ANY BUSINESS YOU MAY HAVE WITH THE COURTHOUSE OFFICES BY PHONE, ONLINE OR EMAIL. REGISTRATIONS MAY BE DONE ONLINE AS GOVERNOR ABBOTT HAS EXTENDED EXPIRED REGISTRATIONS FOR 60 DAYS. PAYMENTS FOR TAXES WILL ONLY BE ACCEPTED BY MAIL OR ONLINE PAYMENT.**
- 4. PLEASE DESIGNATE ONE PERSON TO PROCESS ANY NECESSARY TRANSACTIONS UNLESS TWO PARTIES ARE REQUIRED AND DO SO BY PRIOR APPOINTMENT TO THE EXTENT POSSIBLE.**
