Item 6. Penalty

- ... 1 to 30 days late remitting tax due: Enter penalty of 5% (0.05) of Item 5.
- ... 31 to 60 days late remitting tax due: Enter penalty of 10% (0.10) of Item 5.

Item 7. Interest

... Over 60 days late remitting tax due: Enter interest calculated at the rate of 10% (0.10) a year of Item 5 beginning 60 days after the date on which the tax was due.

As of March 1, 2023, Real County started collecting lodging occupancy tax in the areas of Real County. The amount of tax that you as a lodging operator should collect from your guests on behalf of Real County is 4%. This is in addition to the 6% tax that you collect for the State. Guests who stay in any lodging facility in Real County will be subject to an occupancy tax in the total amount of 10%.
